PUBLIC NOTICE No. 04/2014

- 1. The Central Government has appointed the V.O. Chidambaranar Port at Thoothukudi as Customs Port for the purpose of unloading of imported goods and loading of Export goods or any class of such goods vide Notification No. 62/1994-Cus.(NT) dated 21.11.1994, as amended, issued under section 7 of the Customs Act, 1962.
- 2. In exercise of powers conferred on me under section 8(a) of the Customs Act, 1962, I, P.V. Subba Rao, Commissioner of Customs, Custom House, Thoothukudi, hereby approve VIII Berth Container terminal in Zone A of V.O.Chidambaranar Port in Thoothukudi District of the State of Tamil Nadu and awarded to M/s. Dakshin Bharat Gateway Terminal Private Limited, Mumbai (DBGT), Mumbai as the "proper place" as per limits specified in the table below for the unloading and loading of Export and Import goods in containers.
