Attention of the Clearing Agents, Steamer Agents, Exporters, Importers and their representatives is invited to the Public Notice No. 55/2001 dt. 22.10.2001 issued by the Commissioner of Customs, Trichy declaring the Container Freight Station of M/s. St. John CFS Park, situated at Survey No. 3/63-B, Harbour Express Road, Tuticorin as 'Customs Area' for the purpose of storage, examination, loading / stuffing of export cargo into containers and examination of unloading / de-stuffing of all containers containing imported goods.

Further reference is invited to Ministry of Commerce (Infrastructure Division) letter no. 16/10/94-Infra-I dated 05.01.2001 conveying the approval for conversion of CFS into ICD, Notification No. 8/2004 (N.T) dated 22.01.2004 and connected Facility Intimation Nos. 8/2005 dated and 09/2005 dated 01.06.2005 (issued from File C.No.VIII/9/2/2005-Cus. Pol.) and Facility Intimation No. 18/2005 dated .08.2005 (issued from File C.No.VIII/9/2/2005-Cus. Pol.) issued from this office.
- 3. Furthermore, reference is invited to this office letter C.No.VIII/14/03/2011 Cus.Pol. dated 27.03.2012 declaring the export shed measuring 30,000 Sq.ft. in addition to the already existed shed for examination and stuffing of export cargo.
- 4. Now, M/s. St. John ICD, Tuticorin has requested to convert the Public Bonded Warehouse (License No. 1/2012 dated 10.04.2012) measuring 20,000 Sq. ft. into Export shed for examination and stuffing of export cargo in addition to the existing above mentioned export

shed. As the shed is found to be suitable, the same (measuring 20,000 Sq.ft.) is approved as export shed for examination and stuffing of export cargo under Section 8(b) of the Customs Act, 1962.
