- Compliance if existing Public Bonded warehouse,
Private bonded warehouse licenses - Reg.

Attention of all the public bonded warehouses, private bonded warehouses and all concerned is invited to refer the Public Warehouse Licensing Regulations 2016 (Netification No.70/2016 – Customs (N.T) dt.14.05.2016), Private Conded Warehouse Licensing Regulations 2016 (Notification No. 71/2016 – Customs (N.T) dt.14.05.2016) and Special Warehouse Licensing Regulations 2016 (Notification No. 72/2016 – Customs (N.T) dt.14.05.2016) and the Public Notice No. 16/2016 dated 07.06.2016 issued by this Custom House, Tuticorin.

All existing warehouse licenses appointed under erstwhile Section 57 & 58 of the Customs Act, 1962 are required to fulfil the requirements and conditions specified in the above cited new warehouse licensing Regulations 2016 within one month or three months from the date of notification as applicable and the compliance has to be reported by the licensees to the Commissioner with evidences of compliance. In this regard it is further informed that non-compliance will deprive the right to continue with the licences granted earlier. Therefore all such existing licensees are advised to take necessary steps to comply with the above.
