

## TERMS AND CONDITONS

2. The drivers to be provided for the service shall be in good health and possess heavy vehicle driving licence which should be valid.
3. The out sourcing is for a period of one year for the period from June, 2015 to May, 2016 which is extendable through mutual consent for another one year on the same terms and conditions and charges.
4. The work shall be carried out on shift basis per day viz, Shift-I, Shift-II, Shift-III. Each shift covers 8 hours.
5. Necessary substitute should be provided in case if any one of the Driver is absent on the particular shift.
6. The out sourcing charges will be paid on monthly basis on satisfactory completion of works on production of invoice and subject to the submission of necessary certificate by the respective Officer-in-Charge of the Mobile Scanner.
7. The original Technical Bid will be sealed in a separate envelope and the original Financial Bid will be sealed in a different envelope. Both envelopes will be sealed in a larger envelope. Likewise, a copy of the same documents will be prepared and sealed. Both original and the copy shall be submitted by the due date.
