Sub: Container Freight Station of M/s.Diamond CFS Park,Tuticorin- Inclusion of additional area of 1.80 Acre for storage of Import Containers- Declaration of customs Area under Section 8 of Customs Act, 1962- Approval of- Reg.

Reference is invited to Notification No.1/2009 dated 02.02.2009 read with Facility Intimation No.02/2009 dated 05.02.2009 of the Commissioner of Customs, Tuticorin wherein the premises of M/s. Diamond CFS Park, Tuticorin was declared as Container Freight Station under clause (b) of Section 8 of the Customs Act, 1962 at Survey No.5/51A Senthilampannai Village, Keelathattambarai vilaku, Pudukottai, Tuticorin- 628 103 for the purpose of storage, examination and loading/ unloading of export and import cargo into containers.

2. As requested by the Custodian of the above CFS M/s.Diamond CFS Park, Tuticorin newly developed 1.80 acres falling under Survey No.17/2 has been approved as Customs area. Now, the approved Customs area has been increases from 7.44 Acres to 9.24 Acres.

3. Accordingly, in the above said Notification No.1/2009 dated 02.02.2009 the Second Para under heading DESCRIPTION OF THE AREA AND LOCATION may be read as follows:

"Premises having an compounded area of 9.24 Acres of land owned by M/s. Diamond Shipping Agency Pvt. Ltd., Tuticorin situated at Survey No.5/51A Senthilampannai Village, Keelathattambarai vilaku, Pudukottai, Tuticorin- 628 103 and covered on four side as noted below

BOUNDARIES:

- North By: land bearing survey no.10/1
South by: Pudukottai- Thattabarai road (Survey No.30) and land bearing Survey Nos.17/4, 17/5 & 17/6.
East By : Land bearing Survey No.15(15/1, 15/2B &15/3)
West By : Land bearing Survey No.17/1, 17/6 & 17/7

This Facility Intimation shall come into effect from 30.04.2013.
