Sub: Customs – Drawback/ROSL – Implementation of Rebate of State Levies (ROSL) Scheme – Reg.

Attention of all Exporters/Customs Brokers/Members of Trade is hereby invited to the scheme for implementation of Rebate of State Levies on textile garments (ROSL) with effect from 20.09.2016.

2. Since the implementation of ROSL scheme, totally 1,18,733 shipping bills are filed under the said scheme as on 30.06.2017 at the both the customs locations INTUT1 and INTUT6 and their ROSL status is as follows:

- 3. Out of the above 1,18,733 shipping bills filed under this scheme, 71,387 (60.12%) shipping bills have been scrolled out for the period from 20.09.2016 to 31.05.2017 by this office so far as per ICES Advisory. The main reason for the pendency of ROSL payment in respect of remaining 47,346 shipping bills is error in the bank details viz., account number, IFS Code etc., given by the exporters. In this regard, a Public Notice No.07/2017 dated 22-03-2017 was issued by this office with a request to all garments exporters to provide correct bank details immediately. In response to the Public Notice, numerous exporters have updated their bank account details.
- 4. 47,346 shipping bills for which ROSL payment is pending are filed by 3332 exporters and the bank details given by these 3332 exporters have been verified in the system and their status is as follows:

- 5. At this juncture, it is informed that the shipping bills filed by those exporters (2582 nos.), who have been listed in Annexure-A, would be scrolled out during generation of next ROSL Scroll, and similarly the shipping bills filed by those exporters (466 nos.), as listed in Annexure B, would also be scrolled out during generation of next ROSL Scrolls provided the data furnished is accepted by the PFMS.
- 6. All the remaining 284 exporters, who have been listed in **Annexure-C**, are once again advised to provide correct Bank account details viz., account number, IFS Code etc., to this office forthwith so as to enable disbursement of amount under ROSL scheme smoothly.
- 7. Difficulties, if any, may be brought to the notice of the undersigned.
