**FACILITY INTIMATION NO. 12 /2018**

Sub: Customs- ICES Advisory 08/2018 (IGST Refund) - Option to Rectify Gateway EGM Errors N and C -reg.

Attention of all Exporters /Custom Brokers/Steamer Agents/Shipping Agents/MLO/Line Operators/ Trade and Industry and Public is invited to the Facility Intimation No. 06/2018 dated 18.01.2018 on the above subject.

2. The Directorate of Systems has issued ICES Advisory No. 08/2018 (IGST Refund) dated 09.03.2018 regarding the procedures to rectify Gateway EGM Errors N and C . The same is as follows.


" In continuation to the provision to rectify M and L errors in Gateway EGM filing (ref: ICES Advisory 04/2018 dt 19.02.2018), an option has now been made available in the Preventive Officer role (PREV\_OFF) at Gateway Port to rectify errors **N - Number of Container Mismatch** and **C - Container Number Mismatch** arising out of consolidation of ICD cargo in different container(s) at the gateway port.

The preventive officer can amend container details in the Gateway EGM CTR Amendment Option to remove the mismatch after verifying the package and quantity details and satisfying himself that there is no short shipment. Once the details are corrected, the exporter may be advised to amend the EGM/file supplementary EGM for successful integration.

With this, all options are now available with officers in ICES for rectification of most errors made by Shipping Lines/Custodians, further mitigating the pendency of refunds due to SB006 Error. "

3. All the exporters are hereby requested to take necessary action to rectify the N and L errors in Gateway EGM immediately submitting the self certified copy of the Shipping bill and Bill of lading to the IGST Refund section, Custom House, Tuticorin to resolve the issue of pending claims of IGST refund.

4. Difficulty faced in this regard, if any, may be brought to the notice of this office.
