Sub: Customs- Drawback / ROSL / IGST refund claims not processed due to non validation of the bank accounts of the Exporters by PFMS-reg.

Attention of all Exporters / Custom Brokers/Steamer Agents/Shipping agents/MLO/Line Operators/ Trade and Industry and Public is invited to this office Public notice No. 07/2017 dated 22.03.2017 on the above subject.

- The Directorate General of systems, New Delhi has pointed out that errors in the Bank Account Number, IFSC code etc. given by the exporters lead to non-validation of the bank account by the PFMS, which in turn is resulting in non scrolling out the claims for refund of IGST and Drawback/ROSL amount.
- 3. The List of IECs whose Bank accounts not validated by the PFMS and the list of shipping bills as on 31.05.2018 which are processed, not scrolled out due to non validation of the bank account by PFMS are attached herewith (Annexure-A and Annexure-B).
- 4. In view of the above, the exporters are hereby advised to provide correct Bank account details Viz., Account number, IFS code, IEC code as per the formats attached herewith to the Assistant Commissioner (Drawback), the designated officer of this Custom House. In this regard, Exporter's quick response is solicited, so as to enable disbursement of amount under IGST Refund and Drawback/ROSL scheme smoothly.
- Difficulty faced in this regard, if any, may be brought to the notice of this office.
