As per the directions of Directorate General of Inspection, Customs and Central Excise, New Delhi a next written examination under Regulation 8 of Custom House Agents Licensing Regulations, 2004 is scheduled **to be held on 31.03.2010** at Custom House, Tuticorin. All eligible candidates who are willing to appear for the above Examination may submit their willingness to the Deputy Commissioner(CHA), Customs House, Tuticorin **on or before 12.03.2010**.


2. The candidates who appeared in the written examination 25.05.2009 may also appear in the proposed examination, if required and, if they are otherwise eligible under the provisions of CHALR 2004.

3. The holders of Regular Licence may authorize one or more of their employees or partners or Directors to appear for the examination in addition to the person of their Agency who has passed the Examination.

4. The following documents shall be submitted along with the willingness. Application received without the required documents is liable for rejection.

- i) Letter from the CHA nominating the candidate who are their employee
- ii) Declaration from CHA that the individual is an employee of their concern and is actually engaged in the clearance of goods through Customs.
- iii) Declaration of details of earlier appearances in written examinations
- iv) Attested copy of the Certificate of Educational Qualification
- v) Bio-data with a Passport size photograph affixed on it (in addition to that 4 more photographs to be enclosed along with)
- vi) Conduct Certificate obtained from the a Gazetted officer/ Notary Public
- vii) Attested copy of Form "G"
- viii) Examination fee of Rs.500/- (to be paid only after scrutiny of the application)

PUBLIC NOTICE NO. 01/2010

Subject : Implementation of India Customs EDI System 1.5
(ICES 1.5) at ICD, Tuticorin – Regarding.

Attention of the Importers, Exporters, CHAs, trade and all other agencies concerned is invited to the following Facility Intimation / Public Notices issued by the Commissioner of Customs, Tuticorin regarding computerized processing of Export / Import documents under Indian Customs EDI system, and subsequent public notices issued from time to time :

(i) Facility Intimation No. 8/2005 dated 09.05.2005, Subject : Procedure for computerized processing of Shipping Bills/ Processing of Bills of Entry and Submission of Bill of Entry / Shipping Bill through ICEGATE under the Indian Customs EDI Systems (Imports) at ICD, Tuticorin.

(ii) Public Notice No.22/2007 dated 26.12.2007, Subject : Implementation of Risk Management System (RMS) in Import at ICD, Tuticorin.

(iii) Public Notice No. 21/2007 dated 26.12.2007, Subject : Procedure of e-payment of Customs Duties under the Indian Customs EDI System – ICES at ICD, Tuticorin.

2. Currently, ICES operations at ICD, Tuticorin are being implemented on the standalone system on which LAN based connectivity has been provided to concerned Customs Officers, Service Centres and designated Bank. The system is being managed by officials from the National Informatics Centre.

3. As part of the implementation of CBEC's IT Consolidation Project, the EDI operations at ICD, Tuticorin, would be shifted to ICES 1.5, an enhanced / modified version of the application software currently operational. This software, developed by NIC, would be implemented at CBEC's National Data Centre at New Delhi. The System Integrator for the project is M/s. TCS.

The application would cater to the needs of Customs Officials at ICD, Tuticorin, as also the Service Centre Operators, who would be working on CBEC's new Local Area Network infrastructure implemented by M/s. HP Sales India Private Ltd. Connectivity to the Central servers at the National Data Centre has been provided through CBEC's MPLS network, as part of the Wide Area Networking Project implemented by a consortium led by M/s. BSNL Ltd.

4. The designated Bank's Branch at ICD, Tuticorin would be connected to Central Server to designated Bank through Internet and the bank system would interact with CBEC's Central server through EDI messages. The Service Centres at ICD, Tuticorin would continue to be managed by M/s. CMC, under arrangement with CBEC and there would be no change in the existing charges. Until implementation of EDI message exchange at ICD, Tuticorin custodians would now file Truck Summary for export containers through the Service Centre Operators. An authorized representative of the custodian would sign the checklist and this copy shall be kept in records at the Service Centre to complete the above submission process.

5. The implementation of the new application would entail certain changes in the existing Customs systems and procedure at ICD, Tuticorin. These are being listed below for ease of reference:

- a) The enquiry (document status) facility of users of Service Centre would include document submission status (fresh and amendment) and query status. ICEGATE Document Tracking System (DTS) would also continue to be available.
- b) It may be noted the print out of processed bills of entry and duty payment challans would continue to be obtained by users from Service Centre. However, printout of "Out of Charge" Bills of Entry and Let Export and EP copies of Shipping Bills would now be provided by the Customs Officer(s) designated for the purpose, instead of by the Service Centre Operator.
- c) It may be noted that since the document numbers are to be assigned by the Central Server at the national level, once other ICES 1.5 sites are operational, all document numbers e.g. for Bills of Entry, Shipping Bills, IGMs, EGMs, Challans, would not be in a continuous series for each location.
- d) The duty payment challans would now be provided to the designated Bank through electronic messaging and the bank in turn would electronically confirm payment details to ICES 1.5 system.
- e) Designated bank is advised that the Desk Manager handling challans pertaining to the above location should ensure that the challans accepted on 19.02.2010 by the cash officer are either accepted or rejected. There should not be any document pending

in the Cash Manager's queue at end of day on 19.02.2010 since data from this queue will not be migrated as part of the migration of ICES operations to data center.


- f) The Custodian should note that all Truck summaries which have been filed through Service Centre should be submitted in the system failing which these details will have to be re-entered after migration to data centre.
 - g) For Service Centre operations it may be noted that all documents entered in the Service Centre and pending for submission must be submitted prior to 19.02.2010 failing which these should have to be re-entered after migration of ICES operations to Data Centre. For instance, if for a shipping bill, a job has been entered and not submitted prior to 19.02.2010 it would have to be entered after migration of operations to data centre.
 - h) CHAs filing Import/Export documents would be required to use their PAN based registration numbers, provided by the CHA Section of Custom House, Tuticorin as per the existing practice.
 - i) It may be noted that now in ICES 1.5 generation of temp scroll will be mandatory for dbk scroll generation.
 - j) The specifications for EDI messages for Bill of Entry and Shipping Bills of users filing documents through internet are available on the ICEGATE website : [http:// www.icegate.gov.in/ICES1.5 htm](http://www.icegate.gov.in/ICES1.5.htm). Details of the implementation have also been shared on 02.2010 in a meeting of ICEGATE users with Directorate General of Systems.
 - k) Release advise against various licences will be issued manually.
6. Regarding Helpdesk facilities the following may be noted:
- a) ICEGATE users would continue to interact with the Helpdesk at 011-23379020 and 011-23370133. This Helpdesk is managed by M/s. Wipro.

7. It is proposed to commence live operation of the new application from the National Data Centre FROM 22.02.2010. Consequently all Customs operations on the existing ICD, Tuticorin server would cease with effect from end of day of 19.02.2010. All clearances from end of day of 19.02.2010 till date of launch of application from Data Centre would be handled manually.

8. It may be mentioned that the scheduled implementation at ICD, Tuticorin is the implementation of ICES 1.5. After successful implementation of this project, the new application will be rolled out at other locations across the country. It is expected that this will greatly facilitate clearance of cargo, reduce time taken for clearance, and improve the efficiency of Customs Officers. As this would be a launch of ICES 1.5, users may like to provide feedback for improvement in the working of the system. CBEC would also be making further modifications in the system to enhance functionality of the system and these changes would be notified from time to time.

9. Difficulties, if any, faced by the trade may be brought to the notice of the System Manger ICD, Tuticorin.
