PUBLIC NOTICE No. 02 / 2010

All the Custom House Agents are hereby informed that the Category "G" examination under Regulation 19(3) and 19(6) of the Custom House Agents Licensing Regulations, 2004 **is scheduled to be held on 22.04.2010**, as detailed below:

2. The category "G" examination shall include a written and oral examination. The written examination will be for 100 marks and the minimum qualifying marks will be for 50 marks. Each applicant would be permitted to avail of maximum of four changes / attempts to qualify in the written and oral examination from the date of his / her first appearance for the written examination Non- appearance in any written or oral examination will not be counted as a chance / attempt.

Example: A person who qualifies in the written examination in the first chance/ attempt but fails to qualify in the oral exam linked to the written examination will get another three chances/ attempts for oral examination. If a person qualifies only in his fourth (last) chance /attempt in the written examination, he will get only one chance for oral examination linked to the written examination.

3. On qualifying in the said examination (written and oral) an employee of the CHA will become eligible to hold a Power of Attorney on behalf of his CHA licence.

4. All Custom House Agents are therefore directed to submit a list / application of their present employee who are eligible along with their Photo Identity and willing to appear for the above said Written Examination.

5. **ELILGIBLE FOR CATEGORY 'G' EXAMINATION**

- a) An employee / director / partner holding provisional (temporary) Customs passes in form "H" and who have passed 10+2 or equivalent Examination.
- b) An employee / director / partner holding (Permanent) Customs passes and who have passed 10+2 or equivalent Examination and who desired to have Power of Attorney.

The list of applicant may be submitted in the following format:

6. On passing Written Examination they will have to appear for Oral Test. Further, depending on the number of candidates the Written and Oral Test will be conducted in phases. All the Custom House Agents are accordingly requested to ensure that their employees prepare themselves for the said examination.

7. Custom House Agents are hereby informed that their employees who are holding Provisional Customs Passes in Form "H" are required to qualify in the examination under Regulation 19 of CHALR, 2004 in four attempts (maximum number) from the date of issue of Customs Passes. However, CHA may note that if a candidate does not apply for category "G" examination, it will not be taken an attempt. It is also informed that those employees who have failed to qualify in the last three examinations must ensure that, if they appear, they will have to qualify in the ensuing examination failing which they will not be allowed to appear in the next category "G" examination .

8. The Roll numbers, time, date and venue of the written examination will be displayed on the Notice Board of Custom House, Tuticorin after scrutiny of the application. Further, the list of eligible candidate are required to be **pay Rs. 200/- as examination free** (per candidate). The CHA / candidates will not be informed separately.


9. The applications shall be enclosed with the following:

- a) A copy of the Customs Passes duly Notarised in the prescribed format
- b) A attested Photo copy of 10+2 passed or equivalent exam (original certificates to be shown for verification at the time of submission of applications)
- c) Declaration on previous attempts of "G" card exam.
- d) Declaration of the employer, regarding bonafide of the employee (s) who are sponsored for the exam.

10. All CHA's are directed to ensure that the information given above regarding their employees is true. Any mis-declaration will be viewed seriously and suitable action will be taken in accordance to CHALR -2004.

11. Application which are not prescribed format or are received after **4.00 P.M. on 12.04.2010** will not be entertained under any circumstances
