Sub: Special CHA Written examination for grant of CHA license under CHALR, 2004 to candidates who have qualified under Regulation 9 of CHALR, 1984 – Reg.

1. The Directorate General of Inspection, New Delhi has intimated that as per decision of the Board there is an opportunity for a candidate to qualify the CHA examination in respect of the additional subjects for the currently prescribed course curriculum under CHALR, 2004. Accordingly, a written examination for the candidates who have already qualified under Regulation 9 of CHALR, 1984 but have not been granted CHA license is to be conducted. These candidates have to qualify in the CHA examination in respect of the additional subjects for the currently prescribed course curriculum under CHALR, 2004. **The examination is scheduled to be held on 13th February, 2012 (Monday).** The syllabus (additional subjects) for the said written examination are as under. -

- (1) The Patents Act, 1970 and Indian Copyright Act, 1957;
- (2) Central Excise Act, 1944;
- (3) Export Promotion Schemes;
- (4) Procedure on Appeal and Revision Petition;
- (5) Prevention of Corruption Act, 1988;
- (6) Online Filing of Electronic Customs Declarations;
- (7) Narcotic Drugs and Psychotropic Substances Act, 1985
- (8) Foreign Exchange Management Act, 1999

2. All the candidates who have passed the examination conducted under Regulation 9 of CHALR, 1984 from Tuticorin are eligible to take up the said exam.

3. All the applicants who intend to take the examination may submit their applications giving their particulars in the enclosed proforma (along with recent passport size photograph and attested copies of proof of having passed the Regulation 9 Exam from Tuticorin) so as to reach this office **on or before 07-12-2011.**

4. The applications received after the last date will not be considered for the above examination and no further correspondence in the matter will be entertained.


