PUBLIC NOTICE NO. 12 /2012

Sub: Declaration of Container Freight Station setup by M/s.Chola Logistiks Pvt Ltd., Door No.121, Harbour Express Road, Tuticorin at Tuticorin Port as Customs Area under Section 8(b) of Customs Act 1962 for handling both import and export cargo – Procedures to be followed - Regarding.

In exercise of the powers conferred under Section 8(b) of the Customs Act 1962, the premises of CONTAINER FREIGHT STATION situated at No. 121, Harbour Express Road, Tuticorin- 628008 set up by M/s. Chola Logistiks Pvt Ltd., Tuticorin with the approval of Ministry of Commerce vide letter No16/06/2012-infra-1 dated 26.06.2012 is notified as 'CUSTOMS AREA' by Commissioner of Customs, Tuticorin vide Notification No.02/2012 dated 14.08.2012 for the purpose of unloading, destuffing and customs examination of full container load(FCL) containing imported goods and also for the purpose of Customs examination and loading/stuffing of export cargo into containers under Customs supervision and sealing of the same by Customs with Customs seal.

DESCRIPTION OF THE AREA AND LOCATION OF PREMISES:-

2. The CFS premises having an area of 6.60 Acres of land taken on lease by M/s. Chola Logistiks Pvt Ltd., Tuticorin, situated at 121, Harbour Express Road, Tuticorin, with boundaries on four sides as noted below:-

- North by : National High Way Service Road.  
South by : APM Container Yard. (Survey No.2 B I D)  
East by : Immanuel Weigh Bridge. (Survey No.2 B I B)  
West by : CCFS & Kullothungan Transports. (Survey No. 961)

3. M/s. Chola Logistiks Pvt Ltd., Tuticorin have been appointed as custodian of the goods brought in the aforesaid CUSTOMS AREA for the purposes of Exports and Imports under Section 45 of the Customs Act, 1962 and Handling of Cargo in Customs Areas Regulations, 2009.

4. PROCEDURES TO BE FOLLOWED:-

The procedures for dealing with import FCL cargo and export cargo as laid down in Public Notice No. 26/2004 dated. 13.05.2004 issued by this Custom House and CBEC Circular No.79/2001 dated 07.12.2001 and Circular No.13/2009-Cus dated 23.03.2009 modified from time to time shall be followed. The procedures outlined in CBEC Circular No.55/2000 dated 30.06.2000 and Circular No. 22/2001 dated 17.04.2001 for consolidation of cargo at CFS should be adhered to. Movement of Import laden containers has to be done in accordance with Facility intimation No.13/2006 dated 23.08.2006, Public Notice No.02/2012 dated 02.02.2012 and Facility Intimation No. 02/2012 dated 02.02.2012 of Tuticorin Customs Commissionerate as amended from time to time.

5. This facility will come into effect from 14.08.2012
