





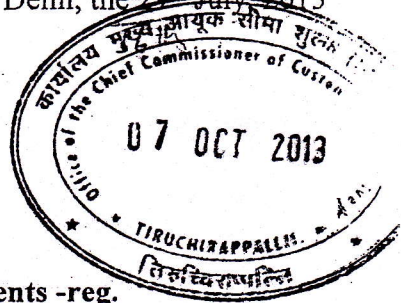

With reference to the matter cited above it is to mention that this office is receiving lot of samples referred by the Customs for examinations to ascertain the export/import permissibility under the Provisions of the Wildlife (P) Act 1972 and CITES. Due to the exigencies of works, various mandates of the Bureau and paucity of staff, it is not feasible to check all referred parts and products on 100% basis.

It is therefore requested to kindly advise the field formation of your jurisdiction to refer only the suspected samples/shipment to this office.

Moreover, it is further requested to kindly not to refer the shipment of following items to this office:

- 1) Bone and Horn handicraft items
- 2) Finished leather/tanned/salted/suede/napa/chrome vegetable/laminated/pull up/upper leather/Wet blue leather/sole leather/holster/synthetic leather etc.
