Sub: Customs – Custom Brokers Licensing Regulation, 2013 – Form <u>G</u> <u>Examination</u> (written and oral examinations) under Regulation 17(3) of CBLR, 2013 for the year <u>2014</u> – Regarding

The "G" card Examination under Regulation 17(3) of Customs Brokers Licensing Regulation, 2013, <u>for the year 2014</u> will be held as per the following schedule:-

Date of issue of Admission Cards	25.08.2014 (Friday)
Date and Venue of written examination	<b>30.08.2014 (Saturday)</b> <b>10:00 hours to 13:00 hours</b> Venue will be intimated later

#### **1. ELIGIBILITY:**

1.1 Employees of the Customs Brokers having valid "H" card who have passed at least 10+2 or equivalent may apply for the "G" card Examination.

# 2. DETAILS OF THE EXAMINATION:

2.1 The examination tests the candidate's knowledge of Customs Act and procedures related to clearance of goods and baggage through customs. It has two parts:-

(a)	Written Examination (Both objective and subjective questions)	3 hours	100	50
(b)	Oral Examination		100	50

# 2.2 Each applicant may avail of a maximum of four chances / attempts from the date of first appearance for the Written Examination.

2.3 If a person qualifies in the Written Examination but does not qualify in the Oral Examination, he/she can use his/her remaining chances to appear directly in the subsequent Oral Examinations i.e., he/she need not appear in the Written Examination again. If a person applies for the Form G examination but does not appear in the Written Examination, it will not be counted as an attempt. If a person qualifies in the written

examination only in his/her fourth attempt, he/she will get only one chance for the Oral Examination linked to that Written Examination.

2.4 The candidates should report at 9:00 AM at the venue of Examination mentioned in the admit card with the original "H" Pass and Admit Card.

#### 3. HOW TO APPLY:

- 3.1 Customs Brokers holding regular CB Licence under Regulation 7 read with regulation 8 of CBLR, 2013 may forward applications of their eligible Employees, partners and Directors with a single covering letter giving the total number of candidates and duplicate copy of SC 34 receipt(s) evidencing payment of examination fee @ Rs. 300/- per candidate so as to reach by 6 PM on the last date for receipt of application
- 3.2 The Application for each candidate should have:
  - (a) Annexure I filled and signed by the candidate and the 'declaration by the Customs Broker' signed by the Partner / Director / Proprietor of the CB with official seal and name in block letters.
  - (b) Passport size photograph pasted on Annexure I, signed by the candidate and attested by the customs broker.
  - (c) Annexure II in duplicate filled by the candidate with a recent passport size photograph pasted. The candidate should sign both on the annexure and on the photograph.
  - (d) Attested copy of 'H' card (both sides).
  - (e) Attested copy of certificate / marksheet of qualification (minimum 10+2 or equivalent).

#### 4. EXAMINATION FEE:

- 4.1 The CB forwarding the applications should pay an examination fee of Rs.300/- (Rupees Three Hundred only/-) per candidate in the accounts section of the Custom House, Tuticorin.
- 4.2 Fees once paid shall neither be refunded nor transferred nor adjusted against any future examination, under any circumstances.

#### **5. INVALID APPLICATION:**

- 5.1 Applications which are not as specified in section 3 above, which are incomplete or which are received after the last date will be summarily rejected. No further correspondence in this regard will be entertained. No further correspondence in this regard will be entertained.
- 5.2 In all cases the decision of the Commissioner of Customs, Custom House, Tuticorin regarding validity of the application shall be final.

#### 6. MOBILE PHONES BANNED:

6.1 Mobile phones, pagers or any other communication devices are not allowed inside the premises where the examination is being conducted. Any infringement of these instructions shall entail disciplinary action including ban from future examinations.

- 6.2 Candidates are advised in their own interest not to bring any of the banned items including mobile phones/pagers to the venue of the examination, as arrangement for safe-keeping cannot be assured.
- 6.3 Candidates are advised not to bring any valuable/costly items to the Examination Halls, as safe-keeping of the same cannot be assured. This office will not be responsible for any loss in this regard.
