2. Candidates who qualified in the written examination held on 05.09.2012 in this Commissionerate but did not qualify in the oral examination conducted earlier on 5<sup>th</sup> and 6<sup>th</sup> April 2013 are also eligible to appear in the Oral Examination (interview).
3. The interview will be conducted either in the morning session (9.30 A.M. to 01.30 P.M.) or evening (02.30. P.M. to 06.30 P.M.) or both sessions. The exact session when the candidates should appear for the interview would be intimated later. Candidates are required to report at the venue mentioned above positively half an hour in advance. Candidates who do not report at the venue mentioned above at the scheduled date and time will not be allowed to appear in the interview and will be marked absent.
4. Candidates should carry original admission card / hall ticket issued by this Commissionerate for appearing in the written examination and produce the same at the time of interview.
5. Candidates have to make their own arrangements for transportation, boarding and lodging.
6. Eligible candidates who are desirous of appearing in the Oral examination (Interview) should report to the Superintendent of Customs (CBLR), Custom House, Tuticorin with the original admission card / hall ticket issued by this Commissionerate for appearing in the written examination on or before 30.09.2014.
