**PUBLIC NOTICE NO. 19 /2014**

Attention of all the Importers/ Customs Brokers is invited with regard to the **DGFT Public Notice No. 73 (RE-2013)/2009-2014 dated 18.11.2014, Public Notice No. 77 (RE-2013)/2013-2014 dated 01.12.2014 and APEDA Trade Notice dated 21.11.2014 for the procedure for export of Organic Products** wherein it is laid down that any product will be allowed to be exported as "Organic Product" only when accompanied by a Transaction Certificate issued by a Certification Body accredited by National Accreditation Body (NAB) for Organic Products under National Programme for Organic Production of the Department of Commerce.

2. It is also laid down that "Organic Products" for export will be so certified only if Produced , Processed and Packed as per the standards laid down in the "National Programme for Organic Production (NPOP)", available on the website of APEDA [http://www.apeda.gov.in/apedawebsite/organic/Organic\\_Products.htm](http://www.apeda.gov.in/apedawebsite/organic/Organic_Products.htm), as amended from time to time.


3. This Public Notice No. 73(RE-2013)/2009-2014 dated 18.11.2014 supersedes the earlier Public Notice dated 21.07.2004 and **would come into effect from 18.12.2014.**

4. The procedure for the issuance of Transaction Certificates for the export of Organic Products has also been laid down in the APEDA above mentioned Trade Notice.

5. In terms of Section 3(3) of the Foreign Trade (Development & Regulations) Act, 1992, all prohibitions imposed under the said Act shall deem to be prohibitions imposed under Section 11 of the Customs Act, 1962. **As such from 18.12.2014 no goods would be allowed for export without proper certificate.**

6. Any discrepancies noticed or difficulties faced may kindly be brought to the notice of the Assistant Commissioner (CFS/EXPORT) for further necessary action.
